## Preliminary Damage Assessment Report

# New Hampshire – Severe Winter Storm and Snowstorm Denial of Appeal

### Denied on December 23, 2023

On May 12, 2023, Governor Christopher T. Sununu requested a major disaster declaration as a result of a severe winter storm and snowstorm during the period of March 13-15, 2023. The Governor requested a declaration for Public Assistance for eight counties, snow assistance for two counties, and Hazard Mitigation statewide. On June 9, 2023, the Governor's request was denied. On September 6, 2023, Governor Sununu appealed the denial. During the period of March 31 to May 11, 2023, joint federal, state, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested areas and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the state and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On December 23, 2023, the Governor's appeal for a major disaster declaration was denied based on the determination that the impact from this event is not of the severity and magnitude that warrants a major disaster declaration.<sup>2</sup>

<sup>&</sup>lt;sup>1</sup> The Preliminary Damage Assessment (PDA) process is a mechanism used to determine the impact and magnitude of damage and resulting needs of individuals, businesses, public sector, and community as a whole. Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

When a Governor's request for major disaster assistance under the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).

o Affected – some damage to the structure and contents, but still habitable.
