- Kewe Cultural (archaeological) monitors kewe re kan angang won kewe pisek ika aramas ra nomotam non pwun, repwe angang non kewe neni e watte ewe kar.
- Kewe Cultural monitors repwe nom otun enemenim. Kei monitors pwisin seni ewe fonu Maui, ra sine me weiweiti ar angang ren pwisin porousen fonuwer.
- Ika mwo kewe jon angang re men forocho ar angang non kewe neni mi or chon maa ren ewe kar, nge ren pochokunun ewe kar epwe or kamon sisapw tongeni chiwen esina. Ren ekei sokun kewe jon angangen enimenim repwe awora porous ika informationren.

1. Aninisin enimenimen pisek me aramas

- Kewe Maui County re need ar repwe angei ewe taropwen right-of-entry seni kewe imw repwe enimenim.
- . Omw mwumwuta mi need ren kewe angangen government contractors repwe tonong won omw property ar repwe ioni piipii ra kar.
- Ren omw ka sign ewe right-of-enrty **ese transfer ewe ownership ren ewe property**. Echok mwut ngeni kewe angangen government repwe tonong non ewe private property ren ar repwe ioni kewe piipii.
- Mwirin ewe Environment Protection Agency ar ioni kewe pisek ren oil, bainit, me batiri, a pwisin nemeniomw ika **kose mwochen** pwan men non ewe private debris removal program.
