Lepopuntan, USACE ra estimateini pwe ewe angangen nimenim epwe fis eu ier mwirin ra poputa ne enimenim; ra moneta ar repwe mina me angang won ewe schedule. Lapengeni, ewe angangen enimwenimw epwe wesino non December 2024; ei angang a moneta ne wesano me non January 2025.
