SACRAMENTO, Calif. – The Ventura County Disaster Recovery Center (DRC) is opening in Thousand Oaks to provide residents impacted by the California wildfires with local, state and federal disaster resources.

The DRC will be open Monday, Nov. 26, 1-7 p.m. and Tuesday, Nov. 27, from 9 a.m. to 7 p.m.

Normal hours of operation will be: Monday-Friday, 9 a.m. to 7 p.m.; Saturday & Sunday, 9a.m. to 5 p.m.

DRCs are operated by the State of California and the Federal Emergency Management Agency (FEMA) in partnership with other federal, state and local agencies.

DRCs are accessible for individuals with disabilities and access and functional needs. They have on-site communication accessibility tools, including amplified listening devices, Video Relay Interpreting and Cap Tel phones. ASL interpreters are available on request.

Those who use 711-Relay or Video Relay Services can call 800-621-3362 to register. Multilingual options are available and calls are answered from 7 a.m. to 10 p.m. PST, seven days a week.
