## President Donald J. Trump Approves Major Disaster Declaration for Iowa

**WASHINGTON** – FEMA announced that federal disaster assistance has been made available to the state of lowa to supplement state and local recovery efforts in the areas affected by severe storms and flooding beginning on March 12, 2019, and continuing.

The President's action makes federal funding available to affected individuals in Fremont, Harrison, Mills, Monona, and Woodbury counties. Assistance can include grants for temporary housing and home repairs, low-cost loans to cover uninsured property losses, and other programs to help individuals and business owners recover from the effects of the disaster.

Federal funding is also available to the state, tribal and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work damaged by severe winter storm, straight-line winds and flooding in Adair, Allamakee, Audubon, Boone, Bremer, Buena Vista, Butler, Calhoun, Carroll, Cass, Cherokee, Clay, Crawford, Dallas, Decatur, Dickinson, Emmet, Fayette, Franklin, Fremont, Greene, Guthrie, Hamilton, Hancock, Hardin, Harrison, Howard, Humboldt, Ida, Iowa, Jasper, Kossuth, Lyon, Madison, Mahaska, Marshall, Mills, Monona, Montgomery, O'Brien, Osceola, Page, Plymouth, Pocahontas, Polk, Pottawattamie, Sac, Shelby, Sioux, Tama, Union, Webster, Winnebago, Winneshiek, Woodbury, and Wright counties. As part of the Public Assistance Program, assistance for debris removal and emergency protective measures (Categories A and B), including direct federal assistance, will be provided at 75 percent federal funding.

Federal funding is also available on a cost-sharing basis for hazard mitigation measures statewide.

Timothy J. Scranton has been named as the Federal Coordinating Officer for federal recovery operations in the affected area. Scrantion said additional designations may be made at a later date if warranted by the results of further damage assessments.
