# Disaster Recovery Centers: What's Open, What's Closed

While some Disaster Recovery Centers in Kentucky have closed permanently, other locations remain open to help survivors of the December tornadoes apply for federal assistance. The deadline to apply is **Friday**, **Feb. 11**.

To find an open Disaster Recovery Center, visit <u>fema.gov/drc</u> or call the **FEMA Helpline at 800-621-3362.** Recovery center hours are 8 a.m. to 6 p.m. local time (weather permitting) Monday to Friday, closed Sunday.

You may visit any Disaster Recovery Center and meet with FEMA staff and representatives of other federal and state agencies. Specialists at the centers are available to answer your questions, including those about delays in receiving a response from FEMA about your eligibility for assistance. They can also help to upload documents to your account.

The centers also allow access to technology equipment for those with disabilities. If you need specialized technology equipment, tell the specialist when you call the **FEMA Helpline**.

Survivors who are unable to visit a recovery center have other options to apply for FEMA assistance: visit <u>DisasterAssistance.gov</u>, use the FEMA mobile app or call the FEMA Helpline at 800-621-3362. If you use a relay service such as video relay service (VRS) or captioned telephone service, give FEMA the number for that service. Helpline operators are available from 7 a.m. to 10 p.m. daily. Press 2 for Spanish. Press 3 for an interpreter who speaks your language.
