

# FY 2024 Nonprofit Security Grant Program Fact Sheet

In Fiscal Year (FY) 2024, the U.S. Department of Homeland Security (DHS) is providing \$454.5 million for facility hardening and other physical and cyber security enhancements and activities to nonprofit organizations that are at high risk of terrorist or other extremist attack.

## Overview

The FY 2024 Nonprofit Security Grant Program (NSGP) is one of three grant programs that support the DHS/FEMA focus on enhancing the ability of state, local, tribal and territorial governments, as well as nonprofit organizations, to prevent, protect against, prepare for, and respond to terrorist or other extremist attacks. These grant programs are part of a comprehensive set of measures authorized by Congress and implemented by DHS to help strengthen the nation's communities against potential terrorist or other extremist attacks.

## Funding

The original FY 2024 NSGP Notice of Funding Opportunity (NOFO) made available \$274,500,000 in funding as provided under the 2024 DHS Appropriations Act. The first amended NOFO made available an additional \$160,000,000 in supplemental funding for the FY 2024 NSGP as provided under the National Security Supplemental (Israel Security Supplemental Appropriations Act, 2024). This second amended NOFO makes available a further \$20,000,000 in supplemental funding provided under the National Security Supplemental (Israel Security Supplemental Appropriations Act, 2024). The supplemental funding has been split equally between NSGP-Urban Area (UA) and NSGP-State (S).

Eligible applicants that were eligible applicants for the initial NOFO and first amended NOFO do not need to submit a new application to be eligible for the additional funding under this second amended NOFO.

NSGP-UA funding will be awarded to nonprofit organizations that are located within one of the FY 2024 Urban Area Security Initiative (UASI)-designated high-risk urban areas. NSGP-S funding is for nonprofit organizations located outside the FY 2024 UASI-designated high-risk urban areas. The FY 2024 NSGP NOFO includes a list of the FY 2024 UASI high-risk urban areas.

## **Eligibility**

The State Administrative Agency (SAA) is the only entity eligible to apply for FY 2024 NSGP funds. The SAA applies to FEMA on behalf of eligible nonprofit organizations (subapplicants) that are at high risk of terrorist or other extremist attack. Eligible nonprofit organizations are those organizations described under section 501(c)(3) of the Internal Revenue Code of 1986 and exempt from tax under section 501(a) of such Code. For NSGP-UA, nonprofit organizations must be located within one of the FY 2024 UASI-designated high-risk urban areas listed in the FY 2024 NSGP NOFO. For NSGP-S, nonprofit organizations may be located anywhere within a state or territory outside of a UASI-designated high-risk urban area.

## **Management and Administration**

SAs can use up to 5% of their total NSGP-S and NSGP-UA awards for management and administration (M&A) purposes. Nonprofit organization subrecipients may also continue to use up to 5% of their subaward for M&A purposes.

## **Funding Guidelines**

FY 2024 NSGP allowable costs are focused on security-related activities. Funding can be used for contracted security personnel; security-related planning, exercises, and training; and the acquisition and installation of security equipment (including improvements) and cybersecurity measures on real property (including

buildings) owned or leased by the nonprofit organization at the time of application.

Starting in FY 2024, there is no longer a requirement to submit a waiver related to the Personnel Reimbursement for Intelligence Cooperation and Enhancement of Homeland Security Act of 2008 (PRICE Act) for contracted security personnel costs under NSGP. Please refer to Section D.12.f.vii of the NSGP NOFO for more information on contracted security personnel costs.

## Application Process

Applying for an award under the NSGP is a multi-step process. Applicants (SAAs only) are encouraged to register early in the System for Award Management ([SAM.gov](https://sam.gov)) and the FEMA Grants Outcomes ([FEMA GO](https://fema.gov)) system, as the registration process can take four weeks or more to complete. Registration should be done in sufficient time to ensure it does not impact your ability to meet required submission deadlines. Please refer to Section D in the FY 2024 NSGP NOFO for detailed information and instructions.

All application materials will be posted on [Grants.gov](https://grants.gov). Eligible applicants should submit their application through FEMA GO. Completed applications must be submitted in the FEMA GO system no later than 5 p.m. ET on June, 24, 2024.
