Opportunity and FY 2018 AFG Awards

I. Purpose

This Information Bulletin (IB) modifies the Fiscal Year (FY) 2018 Assistance to Firefighters Grant (AFG) program reporting, period of performance, and amendment requirements contained in the Notice of Funding Opportunity (NOFO). The Federal Emergency Management Agency (FEMA) acknowledges the delays in the successful deployment of grants management functionality for reporting and amendments via the FEMA Grant Outcomes (FEMA GO) system. In response, FEMA is providing a one-time, 12-month extension to all FY 2018 AFG awards. Further, FEMA is delaying the timelines for required performance reports.

FY 2018 AFG recipients will not need to request an amendment to receive this onetime, 12-month extension to their period of performance. FEMA will automatically provide the extension to the current end of the period of performance listed within all grant awards. All recipients will be notified with amended award documentation for their files.

Although FY 2018 AFG recipients are still required to submit the Federal Financial Report (SF-425) and performance reports, that requirement is deferred until the FEMA GO system functionality has been successfully deployed. Recipients will be provided with a timeline for submission of these reports as soon as it is available.

II. Applicability

This IB applies to FY 2018 AFG recipients.

III. Guidance

- A. The terms of the original FY 2018 AFG NOFO released on February 20, 2020 required recipients to submit an amendment requesting a Period of Performance extension for the project, as discussed on pages 22 and 23 of the FY 2018 AFG NOFO, which can be found on the FEMA website. As directed by this IB, these requirements are waived for this one-time extension in the FY 2018 AFG program. The NOFO requirements for extensions will apply for any additional extension requests.
- B. The terms of the original FY 2018 AFG NOFO released on February 20, 2020 required recipients to submit a Federal Financial Report (SF-425) on a semi-annual basis, as discussed on pages 20 and 21 of the FY 2018 AFG NOFO, which can be found on the FEMA website. As directed by this IB, these requirements are deferred for the FY 2018 AFG program until the FEMA GO system functionality is available. Recipients will be provided additional guidance on submitting these reports, when available.
