

# Georgia Drought Conditions – Denial

## *Denied on March 3, 2008*

On October 20, 2007, Governor Sonny Perdue requested a major disaster declaration due to prolonged drought conditions beginning on September 28, 2007, and continuing. The Governor requested a declaration for Disaster Unemployment Assistance (DUA) and Public Assistance (Categories B, D, and F), including direct Federal assistance, for 85 counties and Hazard Mitigation for all counties. During the period of October 30 to November 2, 2007, joint Federal, State, and local Preliminary Damage Assessments (PDAs) were conducted in 20 of the 85 requested counties and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, are considered in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the State and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On March 3, 2008, the Governor's request for a major disaster declaration was denied based on the determination that the damage was not of such severity and magnitude as to be beyond the combined capabilities of the State and affected local governments.<sup>2</sup>

<sup>1</sup> The preliminary damage assessment (PDA) process is a mechanism used to determine the impact and magnitude of damage and resulting needs of individuals, businesses, public sector, and community as a whole. Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

<sup>2</sup> When a Governor's request for major disaster assistance under the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).

<sup>3</sup> Degree of damage to impacted residences:

- Destroyed – total loss of structure, structure is not economically feasible to repair, or complete failure to major structural components (e.g., collapse of basement walls/foundation, walls or roof);
- Major Damage – substantial failure to structural elements of residence (e.g., walls, floors, foundation), or damage that will take more than 30 days to repair;
- Minor Damage – home is damaged and uninhabitable, but may be made habitable in short period of time with repairs; and
- Affected – some damage to the structure and contents, but still habitable.

<sup>4</sup> By law, Federal disaster assistance cannot duplicate insurance coverage (44 CFR § 206.48(b)(5)).

<sup>5</sup> Special populations, such as low-income, the elderly, or the unemployed may indicate a greater need for assistance (44 CFR § 206.48(b)(3)).
