Preliminary Damage Assessment Report

Maine – Severe Storms and Flooding FEMA-4764-DR

Declared March 20, 2024

On February 23, 2024, Governor Janet T. Mills requested a major disaster declaration due to severe storms and flooding during the period of January 9-13, 2024. The Governor requested a declaration for Individual Assistance and Public Assistance for eight counties and Hazard Mitigation statewide. During the period of January 20 to February 15, 2024, joint federal, state, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested areas and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the state and the affected local governments, and that Federal assistance is necessary.¹

On March 20, 2024, President Biden declared that a major disaster exists in the State of Maine. This declaration made Individual Assistance requested by the Governor available to affected individuals and households in Cumberland, Hancock, Knox, Lincoln, Sagadahoc, Waldo, Washington, and York Counties. This declaration also made Public Assistance available for Cumberland, Hancock, Knox, Lincoln, Sagadahoc, Waldo, Washington, and York Counties. Finally, this declaration made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures statewide.²

¹ The Preliminary Damage Assessment (PDA) process is a mechanism used to determine the impact and magnitude of damage and resulting needs of individuals, businesses, public sector, and community as a whole. Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

When a Governor's request for major disaster assistance under the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).
