## Preliminary Damage Assessment Report

# Florida – Severe Storms, Straight-line Winds, and Tornadoes FEMA-4794-DR

#### Declared June 17, 2024

On May 22, 2024, Governor Ron DeSantis requested a major disaster declaration due to severe storms, straight-line winds, and tornadoes on May 10, 2024. The Governor requested a declaration for Individual Assistance for Leon County, Public Assistance for 10 counties, and Hazard Mitigation statewide. During the period of May 10-20, 2024, joint federal, state, tribal, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested areas and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the state and affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On June 17, 2024, President Biden declared that a major disaster exists in the State of Florida. This declaration made Individual Assistance requested by the Governor available to affected individuals and households in Leon County. This declaration also made Public Assistance requested by the Governor available to state and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by severe storms, straight-line winds, and tornadoes in Baker, Gadsden, Hamilton, Lafayette, Leon, Liberty, Madison, Suwannee, Taylor, and Wakulla Counties. Finally, this declaration made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures statewide.<sup>2</sup>

<sup>1</sup> The Preliminary Damage Assessment (PDA) process is a mechanism used to determine the impact and magnitude of damage and resulting needs of individuals, businesses, public sector, and community as a whole. Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

- Destroyed total loss of structure, structure is not economically feasible to repair, or complete failure to major structural components (e.g., collapse of basement walls/foundation, walls or roof);
- Major Damage substantial failure to structural elements of residence (e.g., walls, floors, foundation), or damage that will take more than 30 days to repair;
- Minor Damage home is damaged and uninhabitable, but may be made habitable in short period of time with repairs; and
- o Affected some damage to the structure and contents, but still habitable.

The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).
