### Preliminary Damage Assessment Report

# Puerto Rico – Severe Storms, Flooding, Landslides, and Mudslides FEMA-4805-DR

### Declared July 23, 2024

On June 7, 2024, Governor Pedro R. Pierluisi requested a major disaster declaration due to severe storms, flooding, landslides, and mudslides during the period of April 29 to May 10, 2024. The Governor requested a declaration for the Individuals and Households Program and Crisis Counseling under the Individual Assistance program and Public Assistance for 34 municipalities and Hazard Mitigation for the entire commonwealth. During the period of May 13 to June 6, 2024, joint federal, commonwealth, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested municipalities and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the commonwealth and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On July 23, 2024, President Biden declared that a major disaster exists in the Commonwealth of Puerto Rico. This declaration made Public Assistance requested by the Governor available to commonwealth and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by severe storms, flooding, landslides, and mudslides in Adjuntas, Guánica, Lajas, Las Marías, Luquillo, Maricao, Naranjito, Orocovis, Sábana Grande, San Sebastián, Toa Alta, Utuado, and Yauco Municipalities. This declaration also made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures for the entire commonwealth.<sup>2</sup>

<sup>&</sup>lt;sup>1</sup> The Preliminary Damage Assessment (PDA) process is a mechanism used to determine the impact and magnitude of damage and resulting needs of individuals, businesses, public sector, and community as a whole. Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

When a Governor's request for major disaster assistance under the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).
