- ʻOku ngʻue ʻaki ʻa e fakalelei kelekelé ke maluʻi ʻa e moʻuilelei ʻa e kakai ʻo e koló mo e ʻʻtakaí meí he ngaahi fakatamaki meí he efuefu mo e veve ʻoku toe ʻi he ngaahi ʻapi naʻe uesia ʻe he vela vao ʻi Lahainá. Naʻe ngʻue ʻaki foki ʻa e fakalelei kelekele tatau ki he ngaahi ʻapi naʻe uesia ʻe he vela ʻi Kulá.
- ʻE lava ʻo tokoni ʻa hono ngʻue ʻaki ʻo e faitoʻo fakalelei kelekele ʻo hangʻ ko e Soiltac ki hono fakasiʻisiʻi ʻo e fetuʻutaki mo e efuefú mo fakasiʻisiʻi ʻa e fakatamaki ki he mʻnavá ʻi he taimi ʻoku fakaauau ai ʻa e efuefú mo e efú. ʻOku toe tokoni foki ki hono fakasiʻisiʻi ʻo e tafe atu ʻa e ngaahi naunau fakatuʻutʻmakí ki he ʻʻsení mo e ngaahi tafenga vai ofí.

- Ko e hili pʻ hono ngʻue ʻakí ʻoku pakupaku ʻa e faitoʻó, ʻoku ʻikai ke kona ia, pea ʻoku ʻikai ʻilonga ia. ʻOkú ne fakasiʻisiʻi ʻa e lahi ʻo e efu ʻe lava ke mafola ʻi he taimi ʻoku ngaue ai ʻa e efuefú.
