- Faile ha tala mo hoʻo kautaha maluʻi. ʻE ʻoatu ʻe hoʻo tafea, kau pe Renters ʻo kautaha maluʻi ha fakamatala ʻo e fakamaʻopopoʻopo ʻe fie maʻu ke ke ʻoatu ki FEMA. Mahalo ʻe fie maʻu ha taimi ke maʻu ai ʻa e fakamatala ko ʻeni, ko ia faile hoʻo maluʻi ʻi he vave taha. Vakaiʻi foki mo hoʻo fakafofonga maluʻi ke vakai pe ʻoku ʻufiʻufi ʻe hoʻo tuʻutuʻuni ha ngaahi fakamole kehe ki he moʻui (ALE). ʻE lava ke ALE totongi ʻa e hiki ki ha nofoʻanga fakataimi.
- Fakaʻaongaʻi ki fema tokoni he taimi pe ko ia. Kapau ʻoku ʻi ai haʻo maluʻi, fakaha FEMA pea fakahu hoʻo ngaahi fakamatala fakapepa ʻo e fakamaʻopopoʻopo ke toe vakaiʻi ʻi he taimi pe te ke maʻu ai kinautolu. He ʻikai lava ʻe FEMA ʻo fakapapauʻi ho tuʻunga totonu fakaʻosi kae ʻoua kuo kakato ʻa e fakamatala ko ʻeni. Kapau ʻoku ʻikai ke kau ʻi hoʻo tuʻutuʻuni ʻa e ALE, pe kapau te ke fakaʻaongaʻi ʻa e fakamatala ko ʻeni pea he ʻikai pe ke ke lava ʻo nofo ʻi ho ʻapi, ʻe lava ke ke maʻu ha tokoni totongi mei FEMA.

Keep your receipts for three years to show how you spent FEMA grants. Kapau ʻoku ʻikai fakaʻaongaʻi ʻa e paʻanga ʻo hange ko hono fakamatalaʻi ʻi he tohi, mahalo naʻa fie maʻu ke ke totongi fakafoki FEMA pea ʻe lava ke mole ʻa e totonu ke maʻu ha tokoni fakapuleʻanga lahi ange.

ʻE lava ke FEMA ʻomi ha tokoni totongi, kau ai ʻa e ʻuluaki mo e hokohoko atu ʻo e ngaahi pale tokoni, ʻo aʻu ki he mahina ʻe 18 pe fakaʻosinga ʻo e vahaʻataimi ʻo e tokoni mahina ʻe 18, ʻa ia ʻoku muʻomuʻa. ʻE toe fakalangilangiʻi foki ʻe fema ʻa e kau tohi kole ʻi ha mahina ʻe taha ʻo e nofo totongi ʻi he taimi ʻoku fakaʻaongaʻi ai ki ha tipositi maluʻi.
