Fiscal Year 2022 Regional Catastrophic Preparedness Grant Program - FAQs

The Regional Catastrophic Preparedness Grant Program (RCPGP) plays an important role in the implementation of the National Preparedness System. RCPGP supports the building of core capabilities essential to achieving the National Preparedness Goal of a secure and resilient nation by providing resources to close known capability gaps in Housing and Logistics and Supply Chain Management, encouraging innovative regional solutions to issues related to catastrophic incidents, and building on existing regional efforts.

About the Program

1. What is the Fiscal Year 2022 Regional Catastrophic Preparedness Grant Program?

The Fiscal Year (FY) 2022 Regional Catastrophic Preparedness Grant Program (RCPGP), as appropriated by the *Department of Homeland Security Appropriations Act, 2022* (Pub. L. No. 117-103), provides funding to close known preparedness capability gaps, encourage innovative regional solutions to issues related to catastrophic incidents, and build on existing regional preparedness efforts.

2. What is the purpose of the FY 2022 RCPGP?

The purpose of the FY 2022 RCPGP is to build regional capacity to manage catastrophic incidents by improving and expanding collaboration for catastrophic incident preparedness. In support of the <u>2022-2026 FEMA</u> <u>Strategic Plan</u>, the strategic priorities for the FY 2022 RCPGP are equity, climate resilience, and readiness.

Recognizing value of all-hazards emergency preparedness planning, and consistent with the strategic priorities of the FY 2022 RCPGP, the focus areas for the FY 2022 RCPGP are the <u>Core Capabilities</u> of Housing, Community Resilience, and Long-Term Vulnerability Reduction that improve capability levels as reported through the <u>Threat and Hazard Identification</u> and <u>Risk Assessment (THIRA)/Stakeholder Preparedness Review (SPR)</u>. Additionally, applicants should consider the needs of socially vulnerable populations and involve representatives from the affected communities in the development and execution of proposed projects to ensure their needs are sufficiently addressed.

3. How much funding is available under the FY 2022 RCPGP?

In FY 2022, the RCPGP program will competitively award \$12 million, which is consistent with FY 2021.

4. How many awards are anticipated?

FEMA anticipates that approximately 10-20 awards will be made. Applicants are eligible to apply for up to, but no more than, \$1 million.

5. Where is the FY 2022 RCPGP Notice of Funding Opportunity (NOFO) located?

The NOFO is located online at <u>Regional Catastrophic Preparedness Grant</u> <u>Program</u>, as well as on <u>Grants.gov</u>.

6. Who is eligible to apply?

States, as defined by 2 C.F.R. § 200.1 (this definition includes the District of Columbia and territories), and local governments, as defined by 2 C.F.R. § 200.1, are eligible to apply for FY 2022 RCPGP funds. The following eligibility restrictions for these groups apply:

- A state or territory is eligible to apply if one or more of the 100 most populous <u>Metropolitan Statistical Areas (MSAs)</u> per the <u>Census Bureau's</u> <u>2021 Population Estimates</u> (as listed in Appendix A of the FY 2022 RCPGP NOFO: 100 Most Populous Metropolitan Statistical Areas [2021]) is located within the state or territory.
- Additionally, the state or territory must obtain the support of the relevant MSA to apply on its behalf. See Section D.10.b Program-Specific Required Forms and Information in the FY 2022 RCPGP NOFO for additional details on this requirement. Local governments must be located within one of the 100 most populous MSAs. FEMA will accept no more than **one application** per MSA.

Additional guidance on RCPGP-specific eligibility is available in the NOFO.

7. What must applications include?

In addition to the required project narrative, budget worksheet, and standard application forms and agreements as noted on page 25 of the NOFO, FY 2022 RCPGP applications must include:

- For States and Territories Only: A written statement explaining the statewide or multi-state impact of the proposed investment and attesting to the advance coordination and support of at least one of the nation's 100 most populous MSAs located within the state or territory.
- For Local Governments Only: A written statement certifying that the applicant's chief executive (e.g., mayor, city manager, county executive) and, as applicable, the chief executive of the first principal city of the MSA, supports the application as the local government's single application being submitted for consideration by FEMA.
- All Applicants: Names of all entities partnering on the project, including but not limited to state, local, tribal, and territorial governments, non-profit organizations, and other non-government entities, including those partnering as subrecipients. Partner entities can extend beyond the boundaries of the state/territory or MSA and can be in other states/territories or MSAs for the purposes of regional collaboration.
- All Applicants: Letters of support from partner entities or a written statement certifying the involvement and support of all partner entities that will participate in the proposed project and, if applicable, information on

the relationship between the applicant and partnering entities (e.g., existing letters of cooperation/support or administrative agreements, such as Memoranda of Understanding [MOUs]).

8. How must the applications be submitted?

Applying for an RCPGP award is a multi-step process:

- Eligible applicants must submit their initial application through the <u>Grants.gov</u> portal no later than one week before the final application deadline. Applicants needing Grants.gov support should contact the Grants.gov customer support hotline at (800) 519-4726 24 hours per day, seven days per week except federal holidays.
- Eligible applicants will be notified by FEMA and asked to proceed with submitting their complete application package in the <u>Non-Disaster (ND)</u> <u>Grants System</u>. Applicants needing technical support with the ND Grants System, please contact <u>ndgrants@fema.dhs.gov</u> or (800) 865-4076, Monday-Friday from 9 a.m. to 6. p.m. Eastern Time (ET).

Completed applications must be submitted no later than 5 p.m. ET on Aug. 5, 2022. Please refer to the FY 2022 RCPGP NOFO for more details.

9. What are the key dates associated with the FY 2022 RCPGP?

- June 27, 2022: Release date for the FY 2022 RCPGP NOFO and opening of application period.
- Aug. 5, 2022, 5 p.m. ET: Applications due to FEMA.
- Sept. 1, 2022: Anticipated allocation announcement date.
- No later than September 30, 2022: All FY 2022 RCPGP awards made.

10. What is the period of performance?

The period of performance is 36 months.

11. How will applications be evaluated?

Applications must conform to the guidance provided in the FY 2022 RCPGP NOFO. Applications that do not meet eligibility and submission requirements

will not be evaluated. Accepted applications will be evaluated by a review panel comprised of FEMA subject matter experts using a scoring rubric. Below is a summary of the evaluation criteria. **New for FY 2022, the needs of socially vulnerable populations are factored into the scoring criteria.** The full criteria can be found in Appendix C of the NOFO, which details the specific criteria aligned to each of the project narrative requirements and the maximum number of points an application can receive for each criterion. The five (5) base criteria earn up to 100 total possible points. The bonus criterion brings the total to 120 possible points.

1) **Need:** The applicant demonstrates a need for grant funds, including identifying their current capability and a gap/need for a project to build beyond current capability within the core capability of interest. (Possible Points: 0 - 20 max)

2) **Project Design:** The applicant demonstrates an effective and sustainable project approach for building their current capability within the 36-month period of performance, including the specific project implementation, project management, and regional collaboration approaches. (Possible Points: 0 – 35 max)

3) **Impact:** The applicant demonstrates the proposed project's regional impact, including how the project will build the applicant's capability, performance measures the project is expected to achieve, and how the project can be scaled or replicated to benefit national preparedness. (Possible Points: 0 - 25 max)

4) **Budget:** The applicant demonstrates a reasonable and cost-effective budget (based on the budget detail worksheet and project narrative), including explanation of reasonable project costs across the requested categories, the project's relative cost effectiveness and sustainability, and the applicant's ability to manage federal grants. (Possible Points: 0 - 20 max)

5) Bonus: Up to20 bonus points will be applied for project proposals that:

- Benefit multiple states or more than one of the top 100 most-populous MSAs.
- Support socially vulnerable populations based on the Centers for Disease Control and Prevention's Social Vulnerability Index data.
- Address climate resilience with a focus on equity.
- Are submitted by a new or previously unsuccessful RCPGP applicant.
- Commit to a 10 percent or greater cost share in the proposal.
- Are submitted by a new or previously unsuccessful RCPGP applicant.

12. What other resources are available to address programmatic, technical, and financial questions?

FEMA Regional Offices issue, manage, and close out RCPGP awards. This includes conducting cash analysis, financial and programmatic monitoring, and audit resolution for the RCPGP program.
